To be admitted to GTCC's **Paralegal Certificate Program***, a student must have an AA/AS or BA/BS degree with at least 18 general education credits. ENG-111 or its equivalent is a prerequisite to admission.

- STEP 1: Complete GTCC's admission process.
- **STEP 2:** Register for classes (see below for course sequencing.)
- **STEP 3:** Applicants will initially be placed in the 2-year AAS program until college transcripts are verified by the Program Director, Dr. Pamela Hollern.
- **STEP 4:** Once your transcripts have been verified, fill out the online program change form to be admitted to the Certificate Program at https://my.gtcc.edu/programchange
