

## FEDERAL STAFFORD LOAN REQUEST FORM – SUMMER ONLY

**Directions:** Complete *BOTH* steps below if you are a new loan borrower at GTCC **before** submitting page 2 of this form to the GTCC Financial Aid Office. Please note that it may take up to 48 hours for GTCC to receive confirmation that Steps 1-2 have been completed.

- **Step 1: Complete Online Entrance Counseling at [www.studentaid.gov](http://www.studentaid.gov)**
- **Step 2: Complete Your Electronic Master Promissory Note (eMPN) at [www.studentaid.gov](http://www.studentaid.gov)**
  - If you do not wish to submit your eMPN online, you may print a paper MPN and mail it to Department of Education, 100 Capitol Commerce Blvd, Montgomery, AL 36117. However, this may increase the length of time it takes to process your loans.

### Important information about your summer loan

- *Loans will be divided into two payments in the summer.*
- *You must be enrolled in 6 or more credit hours to receive each loan disbursement.*
- *You must be making satisfactory academic progress.*
- *There will be a 30-day delay for first-time, first year borrowers.*
- *First year borrowers have earned 32 hours or less. Second year borrowers have earned 33 hours or more (excluding developmental credit hours).*
- *Your lender will deduct an origination fee from each disbursement.*

### Know before you owe

Federal Stafford Loans are debts that must be repaid; they cannot be discharged through bankruptcy and your future income tax refunds or wages can be garnished if you default. You must pay back the loan even if you do not complete your program or are unhappy with your education experience. Different repayment options are offered that may help if you are going through a difficult financial period. Borrow conservatively! How do you decide what the right loan amount might be?
